




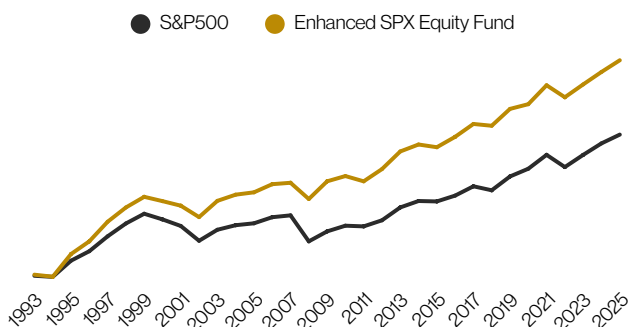
FUND OBJECTIVE

The Enhanced SPX Equity Fund is a systematic equity strategy focused on generating enhanced long-term returns through leveraged S&P 500 exposure combined with volatility hedging and systematic option premium harvesting. The strategy is designed to participate in long-term equity market appreciation while aiming to reduce downside volatility and improve risk-adjusted returns relative to traditional passive index investing.
